2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the three localized primary gastric amyloidosis. The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: Since localized gastric amyloidosis is a very rare metabolic disease, the cases are interesting, and the manuscript has been considered as well-written. However, there are some issues should be addressed.</p>	[Y]

The authors need to add more details in the “case presentation” section. The title has to identify it is a case series study. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 24 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade C. A language editing certificate issued by AJE was provided. But the language needs to be further improved. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the CARE checklist form, and the written informed consent. No academic misconduct was found in the Bing search. The authors have published preprint (<https://www.researchsquare.com/article/rs-34611/v1>). 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; The Outstanding Scientific Youth Fund of Guizhou Province; and the 15851 Talent Projects of Zunyi City. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no “Author contribution” section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
