The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is an interesting study. The manuscript is well written. Nice, simple piece of work, but will need further validation. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 2</p>	[Y]

figures. A total of 32 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by He-Guang Consulting Corporation, Co. Ltd was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The authors need to provide the informed consent. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 13%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The study was supported by Chinese National Science and Technology Projects. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the
