(1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: This is an interesting study of transcriptional landscape of PD-1, PD-L1 and PD-L2 correlated</p>	[Y]

genes in hepatocellular carcinoma. This study is well designed, and the manuscript is well written. Some minor language polishing should be corrected. And the figures are too small, please update the images. The aim of the study needs to be indicated. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 5 figures. A total of 46 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by BioMed Proofreading was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement. The authors need to complete the Conflict-of-Interest Disclosure Form. The study does not involve animals or humans. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Science and Technology Major Project; and Liaoning Province Natural Science Foundation. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no “Author contribution” section. Please provide the author

Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (5) The CrossCheck results showed the similarity to be high.
