The topic is within the scope of the WJCC. (1) Classification: Grade D, Grade B and Grade C; (2) Summary of the Peer-Review Report: There is novelty in the paper and adds to the existing body of knowledge on the subject. think the effectiveness of the IPT in one single patient should be not stated, neither be generalized to other patients with COVID-19, some acute symptoms of anxiety and depression are transitory reactions to COVID-19 and may normalize even without intervention. Nothing consistent should be stated about the IPT for COVID-19 patients unless rigorous randomized controlled trials demonstrate the improvement; and (3) Format: There are 2 figures. A total of 16 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by General scientific research project of Zhejiang Provincial Department of Education; Zhejiang Provincial Medicine and Health Technology Plan Project. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section.
