A total of 7 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) Please write the "Conclusion" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
