The topic is within the scope of the WJGS. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: This article described the resection of the distal gastric tube with preservation of RGEA</p>	[Y]

and RGA for gastric tube cancer. For an 82-year-old patient, with hypertension and chronic renal disease, such a surgical approach maybe reasonable. Please provide images of enhanced CT scans. The language still needs some polishing. A systemic review of all eligible literatures regarding the clinical characteristics and treatment of GTC would be more tempting. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 20 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Textcheck was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation
