The topic is within the scope of the WJH. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Overall the analysis is well-written and performed, but there are few queries which should be answered; and (3) Format: There is 1</p>	[Y]

table and 7 figures. A total of 25 references are cited, including 5 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B. A language editing certificate issued by Research Medics was provided.

3 Academic norms and rules: Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors provided the Biostatistics Review Certificate and PRISMA 2009 Checklist. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 12%. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences.

4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. The corresponding author has not published articles in the BPG. Without financial support.

5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references.

	<p>Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. In addition, the manuscript type should be changed to “Meta-Analysis”.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
