2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the pericardial effusion with tamponade: an uncommon presentation leading to the diagnosis of eosinophilic granulomatosis polyangiitis. The topic is within the scope of the WJC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors described a case of cardiac tamponade complicated with EGPA, which was confirmed by pericardial and lung biopsy.</p>	[Y]

It's rare and interesting; and (3) Format: There is 1 table and 6 figures. A total of 20 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors are from United States. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. The CARE Checklist-2016 is not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required.
