intelligence in order to promote peer learning. A training set including 50 patients is rather small. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 8 figures. A total of 32 references are cited, including 5 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form, and The ARRIVE Guidelines. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by National Research Foundation of Korea (NRF) grant funded by the Korea government. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section.
