The authors should include the type of trauma causing the injuries, and also if these injuries were restricted to upper limb? or there were other organs or structures</p>	[Y]

involved? It is required when the authors approach the study of trauma-related thrombophilia. The fractures were a consequence of the traumatism event, even when the initial D-dimer levels were normal, the late PTE may be preceded by an undetected DVT; and (3) Format: There are 3 figures. A total of 11 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist – 2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Signed Informed Consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Shanghai Fengxian District Osteoarthropathy Clinical Diagnosis and Treatment Center. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
