2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of metastatic pattern in esophageal and gastric cancer. The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors have written a contemporary autopsy series of patients diagnosed with squamous cell or adenocarcinoma of the stomach or esophagus.</p>	[Y]

This is a valuable contribution to the literature and is supportive of prior similar reports. However, there are some issues should be addressed. The authors should indicate that only patients with a diagnosis of metastatic disease were included in this series. This report then reflects only patients with metastatic disease from the outset and does not evaluate patients with locoregional disease who underwent local therapies. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 26 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. The authors need to provide Biostatistics Review Certificate, the Copyright License Agreement signed by all authors, original Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can

be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (6) The authors need to provide Biostatistics Review Certificate, the Copyright License Agreement signed by all authors, original Institutional Review Board Approval Form, and the informed consent. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
