The topic is within the scope of the WJCC. (1) Classification: Three Grades C; (2) Summary of the Peer-Review Report: This is an interesting report on a rare case of delayed anastomotic submucosal abscess after laparoscopic</p>	[Y]

resection of a rectal cancer. The case is well documented and has clinical relevance as an example of mini-invasive treatment of an anastomotic abscess. The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 2 figures. A total of 30 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade C. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China, University innovation team and innovative talent support program of Liaoning Province, and Outstanding Scientific Fund of Shengjing Hospital. The topic has not previously been published in the WJCC.
