appear to be needed to confirm the detailed mechanism of conditioned medium; and (3) Format: There are 4 figures. A total of 33 references are cited, including 24 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form or Document, and The ARRIVE Guidelines are waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 1 national grant.
