2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the retinal organoids derived from human induced pluripotent stem cells. The topic is within the scope of the WJSC. (1) Classification: Grade A, Grade B, and Grade D; (2) Summary of the Peer-Review Report: The study reports the generation of retinal</p>	[Y]

organoids from human iPSC by adapting a method reported earlier in 2014. The protocol seem to work well and generates authentic appearing retinal organoids within 56 days, for downstream applications. Overall, it is a useful study, and it represents a valuable piece of information which potentially could be useful for treating retinal diseases compromising survival of RGC such as Glaucoma. However, it requires rigorous characterization of retinal organoids and isolated RGCs/Muller glia. The abstract should be rewritten. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 34 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. The authors stated that the language was edited by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form or Document, and The ARRIVE Guidelines. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 5 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding
