The topic is within the scope of the WJGO. (1) Classification: Grade B, Grade B, Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: It is a well written paper to evaluate the function of tumor suppressor lncRNA C9orf139 in pancreatic cancer progression and to study the underlying mechanism in a series of</p>	[Y]

54 patients. It adds novel information about PC genetics to the literature. There is a need for minor language revision regarding terminology and expression. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 33 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade B, Grade B and Grade B. A language editing certificate issued by ELLIS was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent, and the STROBE checklist. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the
