2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes an observational study of the motility index measured by MR enterography. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The manuscript is well written and follows a logical sequence. The study limitations include the single center setting and the failure to consider the influence of medical</p>	[Y]

treatment on the disease. This study can act as a basis for future research in this field. Except for CD, the case number of several other diseases, for example UC and dysmotility, was very small. An additional paragraph should be added in the last of the "Discussion" section to present the conclusion of this study. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 31 references are cited, including 8 references published in the last 3 years. There are 7 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent, and the STROBE checklist. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Development Foundation of Region Skåne; Foundation of Skåne University Hospital; and Dir Albert Pahlsson's Foundation. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list.
