NAFLD, which is of potential interest. However, it has several limitations that need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 18 references are cited, including 8 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade C and Grade A. The authors are from United States.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The Institutional Review Board Approval Form, and the Written informed consent are waived. The STROBE Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH.

5 Issues raised: (1) The language classification is Grade C. Please provide the original figure documents. Please add the “Article Highlights” section at the end of the main text.
