clinical implication should be further discussed in the discussion session. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 21 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C and Grade B. The authors stated that the English had been edited by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
