2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the metastatic colorectal cancer. The topic is within the scope of the WJGO. (1) Classification: Grade B, Grade C, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: The manuscript aimed to evaluate the impact of the side of the primary metastatic colorectal tumour on patient</p>	[Y]

survival. They conclude suggesting primary tumour resection offer higher patient survival, independent of tumour sidedness. Although the manuscript does not add utterly new data in the literature, it is well written and the topic of clinical interest. The introduction is too long and compromise manuscript readability. For PTR analysis, patients with metachronous vs synchronous metastases are two different clinical settings. Data from metachronous metastases removing will lead to a more consistent result. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 4 figures. A total of 21 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement. The authors need to complete the Conflict-of-Interest Disclosure Form, provide original Institutional Review Board Approval Form and informed consent, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original
