2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the diffuse coronary artery vasospasm in a patient with subarachnoid hemorrhage. The topic is within the scope of the WJC.</p> <p>(1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors reported a unique etiology of AMI in a patient with SAH leading to ST-segment elevation, diffuse triple vessel coronary artery vasospasm (CAV) and apical scar,</p>	[Y]

which is actual and clinically relevant. However, the authors should better prove that this was an acute myocardial infarction and not a patient with a chronic septoapical myocardial infarction with Takotsubo Syndrome on top due to SAH (which is more probable); and (3) Format: There are 4 figures. A total of 20 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors are the native English speakers. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required by Reviewer 02641731. 7 Recommendation: Conditional acceptance.
