The topic is within the scope of the WJG. (1) Classification: Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: In general, this is a well-planned and designed study. Albeit limited by retrospective</p>	[Y]

design and small case numbers, this study is interesting and might be a reference for healthcare providers who are dealing with acute cholecystitis patients. However, there are some issues should be addressed. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables. A total of 27 references are cited, including 10 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the
