anti-PD-1/anti-PD-L1 antibody therapy in treatment of advanced GC/GEJC patients. The study was well written overall. If some changes are made, the quality of the study will be higher. If you describe the theoretical background in more detail in the Introduction section, it will help you understand. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 9 figures. A total of 44 references are cited, including 22 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Scientific Writing Solutions was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the PRISMA Checklist form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Beijing Hospitals Authority Ascent Plan; Capital Science and Technology Leading Talent Training Project; National Nature and Science Foundation of China; and China Postdoctoral Science Foundation. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant
