symptom have been relieved, this method could combine with some complication, such as bile leakage, purulent peritonitis et al, the long outcome should be observed. The authors need to check English grammar; and (3) Format: There are 3 figures. A total of 10 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by a colleague whose native language was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%.The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. The authors need to fill out the CARE checklist form with page numbers.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report and the full text of the manuscript, of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revision.
