Peer-Review Report: It is the first of its kind study in Singapore Chinese population and is valuable as such. However, there are certain facts to be clarified. This study suffered from several limitations (low sample size, poorly defined inclusion criteria, significant baseline differences between patients and controls). The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 35 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National University Health System. The topic has not previously been published in the WJH. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original
