(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This study adds valuable information to the preexisting bibliography. The research methodology appears to be well structured. article. Minor English revision is required. The authors should also assess whether a specific antithrombotic therapy was correlated with failed endoscopy requiring surgery or embolization. The limitations of the study are not clearly mentioned and should be more clearly summarized in the end of the discussion section. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 3 figures. A total of 31 references are cited, including 5 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. The authors need to provide the language certificate of L'AURACOISE. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the STROBE checklist. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Clinical Research Hospital Program of the French Ministry of Health. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 55372 (Withdraw). 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please revise throughout; and (4) I found the authors did not write the "article highlight" section.
