The topic is within the scope of the WJCC. (1) Classification: Three Grades C and Grade D; (2) Summary of the Peer-Review Report: This is a case that can give attention to many anesthesiologists when perform anesthesia in a patients after esophagectomy. shows the risk even with esophageal atresia. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 20 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Four Grades B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Chongqing Science and Technology Bureau. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.

	<p>Editorial Office Director: I have checked the comments written by the science editor. There is insufficient discussion about prevention of aspiration in cases with gastric tube reconstruction in this manuscript. There are no original findings in this report. The authors need to provide the Copyright License Agreement signed by all authors.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
