The topic is within the scope of the WJH. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: The authors reported a good and well-written review of nearly all studies relating NAFLD and mechanisms and outcomes in non-obese individuals (lean and overweight patients).</p>	[Y]

However, the authors should re-examine the values (20% and 40%) as shown in the Core tips; and (3) Format: There are 2 tables and 1 figure. A total of 90 references are cited, including 25 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade A. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
