The topic is within the scope of the WJO. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: This study is a good work built on a good idea, emphasizing the prognosis of simultaneous hip fracture and proximal humerus fracture. However, some points need to be corrected in the article. Authors should add a statistical analysis paragraph to the method section. It</p>	[Y]

is not enough to state only the name of the program used in statistics. The difference of number of patients between two groups can cause misguided statistic results which lead to clinical significance of this study can be limited. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 7 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors stated that IACUC and IRB were not required in this study. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 11%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the

	<p>references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
