indications. However, there are some issues should be addressed. The authors need to add more details in the “case presentation” section. Please discuss the modalities of the procedure performed and compare/contrast with literature. It is recommended to cite recent references. The questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 10 references are cited, without references published in the last 3 years. The authors need to update the reference. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the CARE Checklist form with page numbers. Written informed consent was waived. Informed consent is not necessary for the study because the authors used anonymous clinical data and the patient died. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND

	<p>FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (3) the author should number the references in Arabic numerals according to the citation order in the text.
