The topic is within the scope of the WJGE. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: In this case control study, the authors studied</p>	[Y]

patients who developed primary gastric cancer after 6 months from confirming H. pylori eradication. The study is interesting, and the manuscript is well written. However, there are some issues should be addressed. The sample size of this study is small, and if no matching been done, the results are hardly convinced. Study flow chart may be valuable. The content of the discussion part of the study is inadequate, the body part does not provide conclusions. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 36 references are cited, including 9 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has published 3 articles in the BPG. 5 Issues raised: (1) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers

	<p>to the reference list and list all authors of the references. Please revise throughout; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
