2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the evaluating efficiency of ALP/PA ratio on GC prognosis. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting study that proposes the use of the ALP to prealbumin ratio (APR) as a prognostic marker for gastric cancer (GC) based on 406 patients from their institution. work is interesting with certain novelty. However, some minor concerns are raised to improve this manuscript. No sample size calculation. Exclusion criteria should contain renal problems and lung problems. Minor English language editing is required. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 34 references are cited, including 15 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No animals are involved in the study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Key Technology Research and Development Program of Shandong. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all
