2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the safety and performance of Everpro® EES with Biodegradable polymer in real-world scenario. The topic is within the scope of the WJC. (1) Classification: Grade D; (2) Summary of the Peer-Review Report: The authors reported an observational, retrospective, single-centre study, the main</p>	[Y]

conclusion of which was that EverPro® EES is a safe and effective treatment option with no MACE or stent thrombosis reported up to 1-year study period. However, the design and methodology need to be revised. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 27 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by CBCC Global Research was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the STROBE Statement, the Institutional Review Board Approval Form, and the Written informed consent. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 8% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
