2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: This is a minireview of the treatment of BRAF-mutant metastatic colorectal cancer. The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors report the current development opportunities and perspectives of the preclinical and clinical studies in BRAF-mutant metastatic colorectal cancer. However, there are some issues should be addressed. The article suffers from a narrative tone, improper use of abbreviations,</p>	[Y]

and still some minor language issues in spite of the “English language editing” performed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 52 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Wordvice was provided. 3 Academic norms and rules: The authors provided the signed and Copyright License Agreement. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJGO. The corresponding author has published 3 articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
