The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: This is a good review article for the GERD in patients with cystic fibrosis. However, there are some issues should be addressed. Tables do not provide any new information and there is a clear displacement of</p>	[Y]

them. A flow chart could be more helpful. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables. A total of 54 references are cited, including 4 references published in the last 3 years. The authors need to update the references. There are 2 self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 56068 (Rejected). 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted). If there are other series of P values, cP < 0.05 and dP < 0.01 are used, and a third series of P values is expressed as eP < 0.05 and fP < 0.01; and (3) I have changed the manuscript type "review" to "minireview". 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
