The topic is within the scope of the WJG. association with chronic hepatitis C which is first time to study this genetic polymorphism in chronic HCV. The quality of statistical processing meets the assigned task and allows you to get objective conclusions. Hetrozygosity and polymorphic information content (PIC) were not calculated in all studied groups to determine whether the single nucleotide polymorphism was polymorphic enough for doing statistical analysis in Chinese population. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 4 figures. A total of 32 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the informed consent, and the STROBE checklist. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Zhejiang Medical and Health Science and Technology Plan Project. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval
