This is an observation and difficult to have conclude any concrete results. But this is the challenge we all are facing due patients staying in home and delaying in seeking care.</p>	[Y]

A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript.
