The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The paper is quite well written and uses an ambitious approach to estimate CE model parameters by collecting real world</p>	[Y]

data from Crohn's patients in a Chinese hospital. This manuscript contributes to the understanding of the CE for an important treatment in a setting with a seemingly low choice of options. However, the paper would benefit from better explanations of key concepts. Please include a discussion on potential problems and inherent uncertainties related to such small patient samples. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 38 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Zhejiang Medical and Health Science and Technology project; and Natural Science Foundation of Zhejiang Province. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant
