of the current article is highly relevant and important. In clinical practice, evaluation of treatment response for various treatment modalities is especially important issue. LIRADS Treatment Response Assessment can provide a possibility as a new framework to describe treatment response because of limitations to the method currently used for response evaluation including mRECIST criteria. To highlight the innovation of your article compared to those of previously similar publications. Language polishing is recommended. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 66 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the
