The topic is within the scope of the WJGE. (1) Classification: Grade C; (2) Summary of the Peer-Review</p>	[Y]

Report: The use of EVT may be one of the alternatives to prevent anastomosis dehiscence. However, compared to other methods of anastomosis protection, EVT is a more invasive procedure and therefore has a higher risk of possible complications. However, the questions raised by the reviewer should be answered; and (3) Format: There are 5 figures. A total of 19 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGE. 5 Issues raised: (1) The language classification is Grade C.
