1、 The authors can rearrange the "CASE PRESENTATION" section as per the sub headings given in the journal's website; journal's case report article guidelines for manuscript preparation: I have revised the case statement in accordance with the guidelines

2、 In the "FINAL DIAGNOSIS" section, the authors have incorporated all the laboratory and imaging investigations. "Final Diagnosis" should include the diagnosis only: I have incorporated all the laboratory and imaging studies are explained separately from the final diagnosis. See revised draft

3、 The histopathological sub-type of the adenoma may be specified: Pathologists in our hospital have difficulty distinguishing subtypes, so they can't tell which subtype it is

4、 Many published literature including case reports and cases series of gallbladder adenoma are available. In the "DISCUSSION" the authors should compare and contrast the nuances of the case report with the literature review.: Subtle differences between case reports and literature reviews have been compared

5、 The uniqueness of the case has been justified by the authors. But the literature review should be extensive and should support the justification of the Case report: The reasons supporting the case report are stated
