Peer-Review Report: This manuscript describes the effect of a new strain of *Pediococcus pentosaceus* administration on the ethanol-induced liver injury. The results have important reference value in the research and treatment of alcoholic liver injury. However, there are some issues should be addressed. The authors need to add more details in the “method” section. Please explain why the number of animals is different between the experimental groups, the control group, the EtOH group, and the *P. pentosaceus* group. The time point of collection of fresh feces needs to be explained clearly. The questions raised by the reviewers should be answered; and (3) Format: There are 7 figures. A total of 51 references are cited, including 13 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Institutional Animal Care and Use Committee Approval Form, and the ARRIVE guidelines. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; the Science Fund for Creative Research Groups of the National Natural Science Foundation of China; and the National Key
