Signed Informed Consent Form(s) or Document(s) was not provided. No academic misconduct was found in the Bing search and the single similar index is 11%, the repeated sentence has to be rephrased. 4 Supplementary comments: (1) Unsolicited manuscript. (3) Corresponding author has not published articles in BPG. 5 Issues raised: (1) The "Article highlights" section is missing, please add this section at the end of the article.
