2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the cholecystectomy reduces subsequent cholangiocarcinoma risk in choledocholithiasis patients who underwent endoscopic intervention. The topic is within the scope of the WJGO. (1) Classification: Grade D and Grade C; (2)</p>	[Y]

Summary of the Peer-Review Report: The authors reported an interesting retrospective article showing that cholecystectomy after endoscopic intervention may reduce the incidence of cholangiocarcinoma in the long term. However, the number of patients required to statistically prove this result. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 43 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Scribendi Inc was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the STROBE Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 7% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Chung Shan Medical University Hospital. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure
