language. Materials and methods are sufficiently detailed. The discussion section explains adequately the purpose of this study in the context of published information. The conclusions accurately and clearly explain the main results; and (3) Format: There is 1 figure. A total of 62 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) As shown in the CrossCheck report, the similarity of the manuscript is a little high. Some parts of the discussion should be revised according to the CrossCheck report. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
