language revision is required. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 35 references are cited, including 5 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the written informed consent, and the CONSORT 2010 Statement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
