(1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: This is an interesting review topic specifically focused on AI application in analyzing colorectal cancer tissue slides. Scientific writing of a review paper and summary of literature can be further improved. Methodology not clear for the</p>	[Y]

technologies mentioned here regarding AI. A figure presentation is recommended to better explain machine learning detection of “hand-crafted” features of the cells. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. A total of 21 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors need to complete the Conflict-of-Interest Disclosure Form and provide the Copyright License Agreement signed by all authors. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents.
