| | 3c | Conclusion: What is the main “take-away” lesson from this case? | <u>Line 28-30/Page 3</u> |
| Introduction | 4 | The current standard of care and contributions of this case—with references (1-2 paragraphs) | <u>1st para/ Page 5</u> |
| Timeline | 5 | Information from this case report organized into a timeline (table or figure) | <u>Figure-1</u> |
| Patient Information | 6a | De-identified demographic and other patient or client specific information | <u>Chief complaints/page 5</u> |
| | 6b | Chief complaint—what prompted this visit? | <u>same as the above part</u> |
| | 6c | Relevant history including past interventions and outcomes | <u>respective part in page 5</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>respective part in page 5</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>respective part in page 5,6</u> |
| | 8b | Diagnostic reasoning including other diagnoses considered and challenges | <u>n/a</u> |
| | 8c | Consider tables or figures linking assessment, diagnoses and interventions | <u>Figure-1/Figure-2</u> |
| | 8d | Prognostic characteristics where applicable | <u>n/a</u> |
| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u>n/a</u> |
| | 9b | Intervention administration such as dosage, frequency and duration page 6 | <u>respective part in page 6</u> |
| | 9c | Note changes in intervention with explanation | <u>page 6</u> |
| | 9d | Other concurrent interventions | <u>page 6</u> |
| Follow-up and Outcomes | 10a | Clinician assessment (and patient or client assessed outcomes when appropriate) | <u>respective part in page 7</u> |
| | 10b | Important follow-up diagnostic evaluations | <u>n/a</u> |
| | 10c | Assessment of intervention adherence and tolerability, including adverse events | <u>n/a</u> |
| Discussion | 11a | Strengths and limitations in your approach to this case | <u>n/a</u> |

| Patient Perspective | 12 | When appropriate include the assessment of the patient or client on this episode of care | <u>2nd para/Page 8</u> |
| Informed Consent | 13 | Informed consent from the person who is the subject of this case report is required by most journals | <u>Page 5 , also as attached files</u> |
| Additional Information | 14 | Acknowledgement section; Competing Interests; IRB approval when required | <u>Page 1</u> |
