The focus of the study is puzzling, for that readers may confuse whether the author focuses on the difference in energy expenditure between cirrhosis and liver cancer patients, or the difference in methodology of expenditure. The reviewer recommends the authors only aim to study one liver disease such as LC or HCC, and the results are more concise and clear. Language needs a great deal of polishing. Therefore, I suggest the Editorial Office director reject this manuscript.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I recommend the manuscript to be published in the World Journal of Gastrointestinal Pharmacology and Therapeutics.</p>
