2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the rare chronic neutrophilic leukemia caused by CSF3R T618I mutation. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors present a case report highlighting the difficulties in the differential diagnosis of chronic neutrophilic leukemia. The article is generally well written and falls within the scope of the journal.</p>	[Y]

The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 3 figures. A total of 28 references are cited, including 7 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Elsevier was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
