2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an observational study of the exenatide once weekly combined with metformin reduced glycemic variability in type 2 diabetes by using flash glucose monitoring system. The topic is within the scope of the WJD. (1) Classification: Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: This article is well written and</p>	[Y]

of clinical interest. However, several issues should be improved. Appropriate captions and legends should be provided in tables and figures, age and sex are necessary data, which should be described in the Abstract, for instance, body mass index, smoking, pre-existing diseases, and complications are also informative. The authors use abbreviations in a manner that makes it difficult to read their manuscript, there is an undefined abbreviation in the first line of their Abstract, there are too many abbreviations in the Results section, undefined abbreviations are used in Figure 1, Table 1, and Table 2; and (3) Format: There are 4 tables and 2 figures. A total of 21 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade C. A language editing certificate issued by CACTUS was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; Special project for transformation and guidance of scientific and technological achievements in Shanxi Province. The topic has not previously been published in the WJD. The corresponding author has no published articles in the BPG. 5 Issues raised: (1) I found the language
